We support a functional justice system in Victoria through effective regulation of the legal profession.

As a regulator, we're empowered by the Legal Profession Uniform Application Act 2014 (Vic) to grant lawyers practicing certificates, and hold them to account for their conduct and competence. We handle complaints from consumers, and work to make sure they are informed about their own rights, and their lawyer's responsibilities.
